

# WARRANTY ON SUNSLATES® ROOFING PRODUCT POWER AND MATERIAL INTEGRITY

## LIMITED TWENTY-YEAR WARRANTY ON POWER OUTPUT

For twenty (20) years from the sale of the product, Atlantis Energy, Inc. will replace the lost power of any modules that fail to produce at least eighty percent (80%) of the minimum power output specified by Atlantis Energy, Inc. at the time of delivery. Atlantis Energy, Inc. will replace such lost power, up to the minimum output originally specified, either by repairing or replacing the module, or by providing additional modules to make up the total wattage lost, at Atlantis Energy's option. This warranty will only apply while the original end user owns the product.

## LIMITED WARRANTY - ONE YEAR

Atlantis Energy, Inc. warrants the Photovoltaic Modules as manufactured to the specifications provided to be free of defects in materials under normal use and service conditions for a period of twelve (12) months from the date of sale to the original end user. If the module becomes inoperable due to a defect in material during the twelve (12) month period of this warranty, Atlantis Energy, Inc will, at its option, repair or replace the product, or if it is unable to repair or replace the product, refund the purchase price.

## WHAT THIS WARRANTY DOES NOT COVER

This warranty does not apply to any modules which have been subject to misuse, neglect of accident, or which has been damaged through abuse, alteration, negligence in use, storage, transportation or handling, or which has been repaired by anyone other than Atlantis Energy, Inc. or an authorized Atlantis Energy, Inc. service representative. This warranty does not cover any transportation costs for the return of the module or cost associated with the installation, removal, or reinstallation of the module manufactured by Atlantis Energy, Inc.

## WARRANTY LIMITATIONS

There is no other expressed warranty on these products. Atlantis Energy, Inc. is not responsible for any incidental or consequential damages arising from the use or loss of use of the product. Any warranties implied by law, including those of merchantability and fitness for a particular purpose, are limited in duration to the term of this warranty. Atlantis Energy's maximum liability under any warranty, expressed, implied, or statutory, is limited to the purchase price of the product. The purchaser's exclusive remedy shall be only as stated herein. Some jurisdictions do not allow limitations on how long an implied warranty lasts or the exclusion or limitations of incidental or consequential damages, so the above limitations or exclusions may not apply to you.

## LIMITED TWENTY-FIVE YEARS MATERIAL INTEGRITY WARRANTY

This expressed warranty covers performance of individual roof tiles only. Atlantis Energy Systems, Inc does not warrant accessory materials or installation labor provided by others

Atlantis Energy warrants that each Eternit slate or SUNSLATES® slate will for twenty-five years of the original residential homeowner remain incombustible, not allow passage of water due to decomposition or decay.

Specified Exclusions. This warranty does not cover: [1] damage to the tile caused during installation; [2] tile not installed according to the printed installation recommendations issued by Atlantis Energy Systems, Inc. or not installed in accordance with appropriate building codes and/or trade practices in that specified area; [3] tile color fading, cracking, chipping or delaminating; [4] defects or failure of other materials used as components of the roofing structure; [5] damage to the tile caused by roof traffic or foreign objects falling on the roof; [6] damage to tile or structures caused by tornadoes, hurricanes or other acts of God; [7] changes or variations of the color hue or physical deterioration of the color for any reason including, but not limited to weathering oxidation or air pollution.

The foregoing is the entire expressed Limited Warranty of Atlantis Energy Systems, Inc. Atlantis Energy Systems, Inc. hereby disclaims all implied and statutory warranties where allowable by law including the implied warranties of merchantability and fitness for a particular purpose. No other person either employee, agent or otherwise is authorized to vary or change the terms of the warranty either orally or in writing. Atlantis Energy Systems, Inc. shall in no event be liable under any circumstances for incidental or consequential damages, or for any damages to any structure or its contents or its occupants. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation may not be applicable to a registered owner who is deemed a consumer under local statutes.

Claims under this Extended Warranty will be honored only if the following conditions are met:

[1] The registration certificate shown here has been properly executed and forwarded to Atlantis Energy Systems, Inc within 90 days of installation or original ownership.

**IN THE EVENT THIS WARRANTY CERTIFICATE HAS NOT BEEN PROPERLY REGISTERED, THE DURATION OF THIS EXPRESSED WARRANTY SHALL BE LIMITED TO TWO (2) YEARS FROM THE DATE OF ORIGINAL INSTALLATION.**

[2] The registered owner notified Atlantis Energy Systems, Inc. promptly after the fact on which this claim is based became known.

[3] Atlantis Energy Systems, Inc has had an opportunity to investigate and approve the claim before any repairs are made.
